All entries must reach us by Friday, 25th April 2013 at 6:00pm. Will reply to all the entries via email within 24 hours so the sender could ensure the entry is received and also it is the responsibility of the sender to check the effectiveness.

Events 10歲組,12歲組及14歲組 單雙打賽事

Boys & Girls 14, 12 and 10 Under (Singles & Doubles).

Age Eligibility 各歲組資格限制

14 Under (Born in 1999 or later) ;12 Under (Born in 2001 or later);10 Under (Born in 2003 or later)

Draw Match 每個項目每國家名額兩名, 超過名額者列入會外賽

2 players in every event for each country. The extra players could join the qualifying.

Hospitality 主辦單位將提供4個房間(雙人房), 並提供6位選手及2位教練給每個參賽國家

The Organizer will provide 4 rooms(double or twin bed room) and three meals for 6 players plus 2 officials from each country.

Entry Fee 報名費:每人100人民幣

RULES and REGULATIONS

1. The ITF tournament rules will be applied in conjunction with this tournament's rules. The Committee reserves the right to change the rules in any way it deems fit and reject any entry without assigning a reason.

2. All events shall be played on a **knockout system**.

3. The **format of play** shall be as follows.

i). (a) **14 and 12 Under Singles** to be played from 1st round to Quarter-final – 1 set of first to reach 8 games with Super Tie-Break at 8 games all. 7-7 play to 9 games.

For **Semi-Final** and **Final** only – Best of 3 sets – 1st and 2nd set Tie-Break sets, and the 3rd set shall be played Super Tie-Break of first to reach 10 points winning with a margin of 2 advantage points.

(b) **10 Under Singles** to be played from 1st round to Quarter-final – 1 set of first to reach 6 games with Tie-Break at 6 games all. 5-5 play to 7 games.

For **Semi-Final** and **Final** only – Best of 3 sets – 1st and 2nd set Tie-Break sets, and the 3rd set shall be played Super Tie-Break of first to reach 10 points winning with a margin of 2 advantage points.

ii). (a) All Double partners **MUST** be of the same aged group of singles

(b) **14 and 12 Under Doubles** to be played from 1st round to Quarter-final– 1 set of first to reach 8 games with Super Tie-Break at 8 games all. 7-7 to play 9 games.

For **Semi-Final** and **Final** only – Best of 3 sets – 1st and 2nd set tie-break sets, and the 3rd set shall be played Super Tie-Break of first to reach 10 points winning with a margin of 2 advantage points.

(c) **10 Under Doubles** to be played from 1st round to Quarter-final – 1 set of first to reach 6 games with Tie-Break at 6 games all. 5-5 to play 7 games.

For **Semi-Final** and **Final** only – Best of 3 sets – 1st and 2nd set tie-break sets, and the 3rd set shall be played Super Tie-Break of first to reach 10 points winning with a margin of 2 advantage points.

The format of play may be changed at the referee's discretion.

4. The **No-Ad Scoring System** will be implemented in this tournament.

*No-Ad Scoring System: If both players have won 3 points, the score is called deuce; one deciding point shall then be played whereby the receiver shall choose whether he/she wishes to receive the service from the right half of the court or the left half of the court. The player who wins the deciding point wins the game.

5. Participants must be prepared to play **3 or more matches a day** with a minimum rest period of 30 minutes in between matches.
6. At this tournament, matches will be played without a Chair Umpire. Players must **keep their own score**. If a player feels that the opponent's line calls are inaccurate, the player should inform the referee IMMEDIATELY. Dispute of any nature regarding a match should be brought to the referee's attention immediately. Protests will not be entertained after a match is completed.
7. **Warm-up:** Strictly 5 minutes only.
8. Match courts are STRICTLY for PLAYERS ONLY. Warm-up courts will be provided before matches.
9. For doubles entry, if one player is unable to play for any reason, the pair will have to concede a walkover as substitute partner is not allowed after the entry deadline.
10. **In the event of rain**, the referee shall make an announcement informing all players to dry their courts when the rain stops. Should any player fail to report 15 minutes after the announcement is made, the player will be defaulted (i.e. concedes a walk-over). No appeal will be accepted.
11. Competitors play at their own risk. The Organizers are not responsible for any injury, loss or other mishaps during the tournament.
12. **No outside coaching is allowed**. Communication of any kind, audible or visible between player and a coach or concerned party shall be construed as coaching. The referee has the discretion to ask any member of the public to move away from the courts. If coaching continues despite being advised by the referee to stop, the player will be defaulted.
13. Any discrepancy on the entry form, i.e. name, age, events etc. shall cause the entry to be rejected. No appeal will be entertained.
14. Any player who violates the Rules and Regulations above shall be defaulted immediately, immaterial of which rounds he/she has reached.
