IMPORTANT INFORMATION FOR VISA UPON ARRIVAL UZBEKISTAN.

Nationals of the following countries do not require visa for a 30 day stay.

A visa-free regime is introduced for 30 days period for citizens of Australian Union, Austrian Republic, Argentine Republic, Bosnia and Herzegovina, Vatican, Grand Duchy of Luxembourg, Hungary, Brunei Darussalam State, Greek Republic, Israel, Indonesia, Ireland, Iceland, Italian Republic, Canada, Andorra Principality, Liechtenstein, Principality of Monaco, the Kingdom of Belgium, the Kingdom of Denmark, the Kingdom of Spain, the Kingdom of the Netherlands, the Kingdom of Norway, the Kingdom of Sweden, the Republic of Latvia, the Republic of Lithuania, Malaysia, Mongolia, New Zealand, Portugal Republic, Republic of Bulgaria, Republic of Cyprus, Republic of Korea, Republic of Malta, Republic of Poland, Republic of San Marino, Republic of Serbia, Singapore, Republic of Slovenia, Republic of Croatia, Republic of Chile, Romania, Slovak Republic, United Kingdom of Great Britain and Northern Ireland, Republic of Turkey, Federative Republic of Brazil, Federal Republic of Germany, Finland Republic, French Republic, Montenegro, Czech Republic, Swiss Confederation, Republic of Estonia, Japan.

All other Nationalities traveling to Uzbekistan MUST go through the online visa application process described below:

- 1. ALL PLAYERS MUST CHECK VISA REQUIREMENTS WITH THE UZBEKISTAN CONSULATE AND WITH THEIR AIRLINE CARRIER IN ADVANCE OF DEPARTURE. INFORMATION IN ENGLISH CAN ALSO BE FOUND ON https://mfa.uz/en/consular/visa/
- 2. PLAYERS WHO HAS THE UZBEKISTANI CONSULATE IN THEIR COUNTRIES:

PLAYERS WHO HAVE AN UZBEKISTANI CONSULATE IN THEIR COUNTRY OF ORIGIN CANNOT APPLY FOR A VISA ON ARRIVAL IN TASHKENT, THEY MUST OBTAIN A VISA BEFORE DEPARTURE. VISAS CAN BE COLLECTED AT AN UZBEKISTANI CONSULATE IN A FOREIGN COUNTRY SO LONG AS THIS IS SPECIFIED IN THE 'PLACE OF VISA ISSUE' ON THE ONLINE FORM, ONLINE APPLICATION REQUIRED. Visa application procedure described below.

3. PLAYERS WHO HAVE NO UZBEKISTNI CONSULATE IN THEIR COUNTRIES:
ONLY PLAYERS WHO HAVE NO UZBEKISTANI CONSULATE IN THEIR COUNTRY OF ORIGIN
ELIGIBLE TO APPLY FOR A VISA ON ARRIVAL. ONLINE APPLICATION REQUIRED. VISA
APPLICATION PROCESS DESCRIBED BELOW.

IMPORTANT NOTICE: PLAYERS WHO APPLY FOR ON ARRIVAL VISA BY THE PROCEDURE BELOW MUST ENTER UZBEKISTAN VIA TASHKENT INTERNATIONAL AIRPORT (TAS) ONLY. THE ON ARRIVAL VISA PROCEDURE IS NOT AVAILABLE AT ANY OTHER AIRPORTS IN UZBEKISTAN.

<u>PLAYERS WHO IS ELIGIBLE</u> TO OBTAIN THE VISA UPON ARRIVAL AT TASHKENT AIRPORT (TAS) MUST NOTE: Visas will cost at least USD\$80 depending on country of origin and when the visa is applied for. Urgent visas will be charged more. Payment for visa will be collected upon arrival at <u>Tashkent airport</u> (TAS) in **CASH** only.

Online Visa application process

All players who qualifies for on arrival visa or who must obtain their visa before traveling must go through the online visa application process:

Players should complete their visa application form online at least ten (10) days before the commencement of the event on http://evisa.mfa.uz Players who must visit the embassy before traveling should apply more in advance.

- 1. <u>Player from the countries who is eligible for on arrival visa</u> in the section of the online form "Place of Visa Issuance" please select "Tashkent Airport"
- 2. * Players who has the embassy at their countries MUST in the section of the online form "Place of Visa Issuance" select the embassy in which they will collect the visa sticker before traveling to Uzbekistan.

*Note: Players arriving from the countries where there is no diplomatic representation or consular mission of the Republic of Uzbekistan can get visas upon arrival at the Visa Section of the Ministry of Foreign Affairs of the Republic of Uzbekistan at the Tashkent International Airport. In this case the players can apply a visa on arrival online. ONLINE VISA APPLICATION REQUIRED AS DESCRIBED ABOVE. Players must provide their air-ticket confirming that they are traveling from a country which has no consulate and send it together with the online application form and color passport copy to Ms. Govkhar utf@tennis.uz ,in this case she will try to apply for the visa on arrival option which need to be approved by the MFA authorities.

Players who has the UZBEKISTANI consulate in their countries having any issues with the travel arrangement and visa related questions MUST contact the Uzbekistani consulate in the countries of citizenship to clarify the procedure.

- 3. Color copy of the passport and completed form with the barcode on it must be emailed to Ms. Govkhar Azimova at the Uzbekistan Tennis Federation by email (utf@tennis.uz). UTF will process your visa and you can track the status of your visa with Ms.Govkhar.
- 4. An applicant must make sure that his/her return ticket within the dates requested for the visa.
- 5. Please ensure that you have confirmation from Ms. Govkhar that your form has been received.

WITHIN A WEEK'S TIME YOU SHOULD RECIEVE 1. THE VISA ON ARRIVAL CONFIRMATION LETTER OR 2. VISA CONFIRMATION LETTER FOR THE EMBASSY YOU APPLYING AT FROM Ms. GOVKHAR.:

- 1. FOR PLAYERS ELIGIBLE FOR ON ARRIVAL VISAS THIS LETTER WILL ALLOW YOU TO CHECK IN AT THE AIRPORT AND BOARD THE AIRCRAFT.
- 2. FOR PLAYER WHO NEEDS TO GET THEIR VISA STAMPED BEFORE TRAVELING THIS LETTER WILL BE REUIRED TO VISIT THE CONSULATE. PLAYERS MUST HAVE WITH THE PRINTED COPIES OF ONLINE APPLICATION AND CONFIRMATION LETTER.

NEW

The government has launched the new e-visa system starting from July 15, 2018. The new system abolishes the mandatory application to diplomatic missions and consular offices of Uzbekistan abroad. The amount of the consular fee for registration and issuance of an electronic entry visa is 20 USD. The e-visa will be issued for the period of stay of up to 30 days with a single entry and will be valid for 90 days from the date of issue. Payment for the visa can be made electronically through international payment systems, and the applicant does not necessarily to be the owner of a bank card. To receive the e-visa, you should apply at least three working days before the planned date of travel to Uzbekistan via https://e-visa.gov.uz./main. The electronic visa will be issued within two working days and sent by e-mail.
