



PLAYER ELIGIBILITY FORM

ATF 12&U INTERCONTINENTAL TEAM COMPETITION SUPPORTED BY KTF

In accordance with Regulation 27 of the ITF Junior Team Competitions, in order to be eligible to represent a nation, a player:

- **Must:**
 - Hold a current valid passport of that nation; or
 - if the nation does not issue its own passport, be a citizen of that nation, and hold a current qualifying passport that shows the player was born in that nation; or
 - have lived in the nation for two consecutive years, does not hold a passport but has a genuine reason for being unable to hold or make an application for a passport, and either:
 - was born or one of their parents or grandparents was born in that nation; or
 - has the right to remain permanently, or has been granted humanitarian protection in that nation;
- **Shall not have represented any other nation at ATF/ITF Junior Team Competition level***

Please note that participation on the ITF Junior Circuit does not count as having represented a nation

- (1) The ITF Junior Team Competition Regulations, with specific reference but not limited to, Article IV (B) Of Appendix B of the ITF Junior Team Competition Regulations **(Conduct Contrary to the Integrity of the Game)** and ITF Junior Team Competition Regulation 60; and
- (2) The Bye-Laws of the ITF with specific reference but not limited to Article 7 (a)

Data Protection Notice

Asian Tennis Federation (ATF) gathers certain information about you. Information about you is also used by our affiliated entities and group companies, namely ITF Ltd (trading as the International Tennis Federation) (our 'group companies').

The information you provide in this form, any supporting material and/or otherwise in relation to your eligibility to participate in the ITF Junior Team Competition includes your personal data (e.g. your name, date of birth, address, passport details, nationality). It may also include personal data related to your family members, whose details you supply to us. We may also obtain information about you from third parties, such as the nation who has selected you to represent them.

We process information about you and third parties for the following reasons:

- Assessing your eligibility to play in the ATF 12&U Team Competition pursuant to the ITF Junior Team Competition Regulations in force from time to time;

We may disclose and exchange information with other tennis organisations, such as any nation that you are also eligible to play for, as well as with any hearing body that has jurisdiction for considering your application or any subsequent appeal.

Information may be held at our offices and those of our group companies. Information may be transferred internationally to other countries around the world, including those without data protection laws equivalent to those in the UK, for the reasons described above. We have security measures in place to seek to ensure that there is appropriate security for information we hold.

Children If the information provided in this form or subsequent to it relates to a person under 16 years of age, we require parental consent. Your parent or guardian should read this notice, and by signing this form, they provide their consent for the ATF to process your personal data in accordance with this data protection notice.

Sensitive personal data You may also supply us with sensitive personal data relating to your racial or ethnic origin, or physical or mental health. If you choose to provide us with this information, you are providing us with your explicit consent for us to process that sensitive personal data, for the purpose of assessing your eligibility to play in the ATF 12&U Team Competition.

We may disclose your sensitive personal data to those persons or organisations with other tennis organisations, such as any nation that you are also eligible to play for, as well as with any hearing body that has jurisdiction for considering your application or any subsequent appeal.
